3. Questions of Staff

- 3.1 In response to Councillor Keith's inquiry regarding pavement work done on either side of the CN tracks that cross Cascade Street, Director of Public Works Mike Kearns reported that CN did the paving work, and subsequent to complaints received on its lack of smoothness, CN has already been contacted to repair this work.
- 3.2 In response to Councillor Borneman's inquiry regarding colour of the granite used on the Fitness Trail, Mr. Kearns confirmed that the colour sourced from the same place as the original material is pink, although there is not a "standard granite pink".
- 3.3 In response to Councillor McCann's inquiry regarding recent fire training, Fire Chief Dave Thompson reported that the 20 recruits from five different area fire departments spent Saturday at the Carling Firehall and then Sunday with different trainers at the Parry Sound Firehall. Chief Thompson noted that this is part of the new 80-hour training program mandated by the province to achieve certification. With respect to a photo in the newspaper, Chief Thompson noted that this was an exercise in

ventilation technique, with the trainees on a pitched practice roof cutting into the roof, to simulate what they might have to do on a real fire scene.

5.1 Sarah Wallace, YMCA Employment and Learning Services RE: Update on Labour Market

Job Developer Sarah Wallace of the YMCA provided an update on the labour market, programs and services, from a prepared statement attached to the Council Agenda. Ms. Wallace concluded requesting that if one knows of a job seeker, or of an employer who needs support, to refer them to the YMCA.

- John Jackson addressed Council on behalf of the development group regarding two matters of concern relating to the proposed Development Charge (DC) By-laws being:
- a) Non-residential fees with an example of a 50,000 sq ft. building at fees close to 1/2 million compared to those in Gravenhurst or Bracebridge at \$125,000.
- b) Option 3 blended DCs and Fees and Charges for water and sewer, noting that through use of the fees and charges, protections afforded under the DC legislation such as exemptions and a phased in approach are not available. Mr. Jackson expressed concern that the loss of these incentives might bring housing builds as envisioned by the province to a stop and that these concerns might be important enough for the development community to appeal the DC By-laws.

Mr. Jackson also suggested that if Seguin proceeds with DCs, the Town and Seguin could ultimately work together seamlessly if only DCs are used, instead of a blend of DCs and fees and charges.

Mr. Jackson asked Council to consider these issues and if necessary, to delay the passage of the DC by-laws by another two weeks.

9.5.5 Support Chronic Pain Sufferers from becoming Addicted to Opioids

WHEREAS THE Ontario College of Physicians and Surgeons is targeting community pain clinics by requiring the use of ultrasound technology in the administration of nerve block injections by licensed physicians; and

WHEREAS this requirement is not mandated for physicians in any other capacity, such as epidurals in hospitals; and

WHEREAS this requirement will increase the time it takes to administer the nerve block and therefore reduce the number of patients a physician can see in a day; and

WHEREAS the Ontario Health Insurance Plan (OHIP) is proposing to reduce coverage for several vital healthcare services, including a reduction in the number and frequency of nerve block injections a patient can receive, forcing chronic pain clinics to shut down and putting a greater strain on family physicians and emergency rooms; and

WHEREAS the reduction in the number of nerve blocks being administered will result in many patients looking for pain relief turning to overcrowded emergency rooms, opioid prescriptions from doctors or opioid street drugs;

NOW THEREFORE the Council of the Corporation of the Town of Parry Sound calls upon the province to maintain OHIP coverage for chronic pain treatments and continue to provide much-needed care for the people of Ontario; and further
