# 2. Public Meeting - N/A

## 3. Questions of Staff

- 3.1 In response to Councillor McCann's inquiry as to how much longer George Street will be closed to accommodate construction of a development, Director of Public Works Mike Kearns reported that the closure is for servicing work and reconstruction of part of George Street for a wider benefit than just the new development. Mr. Kearns noted that the servicing and reconstruction work will be finished soon.
- 3.2 In response to Councillor Borneman's inquiry as to when the bridge at River/Cascade Streets would be finished, Mr. Kearns reported that at a progress meeting today at the bridge, he learned that the work is on schedule and should be completed early to mid-August.
- 3.3 In response to Councillor Borneman's inquiry regarding limbing of trees on the Fitness Trail, Mr. Kearns noted that spreading the material on the Fitness Trail is challenging in some areas, and therefore pruning and limbing has been necessary and the debris still needs to be cleaned up. Mayor McGarvey also reported that limbing work needs to be done around McIsaac Way due to much overgrowth. Mr. Kearns also noted that the growth under the Seguin River bridge needs to be pruned and addressed with a longer term strategy.

3.4 In response to Councillor Keith's inquiry regarding anecdotes of people lighting fireworks over the weekend, Director of Development & Protective Services/Fire Chief Dave Thompson noted that he too had heard that there may have been fireworks set off in Town, although the Fire Department did not receive any calls to deal with anything. Chief Thompson noted that the Department is proceeding with a zero tolerance approach and if they had received calls, they would have investigated and levied fines against the perpetrator.

# 5. Deputations

**5.1** Bob Bowland, Parry Sound Community Radio Association

Parry Sound Community Radio Association Board Director Bob Bowland, former owner of MOOSE FM, (previously named LP 103), addressed Council with respect to the benefits and value of a community radio station. Mr. Bowland provided background on

his own experience in radio culminating in his ownership and management of MOOSE FM. Mr. Bowland provided information on the number of community radio stations in Ontario, typical financing through eligible grants, advertising, radio bingo and draws, their use of volunteer help, and mission to connect with the community at large through local news, weather, and discussions on topics of interest.

Mr. Bowland said that a studio location has been found and the association is in discussion with the Town about use of the Water Tower on Bowes Street for an antennae. Mr. Bowland reported that the municipalities of Seguin and McKellar have provided resolutions of support for the PS Community Radio Association and the Association is seeking the same from the Town of Parry Sound.

Mr. Bowland responded to questions of Council, including employment arrangements and how the effectiveness of radio stations through ratings is measured.

5.2 Doug McDonald, Chair of the local Parry Sound Chapter of Habitat for Humanity addressed Council further to the letter provided under item 4.3 regarding purchasing Town owned Emily Street property upon which to build a house for a family in need. Mr. McDonald noted that the local Chapter has built 4 homes since 2011 and is in a position to build another after COVID temporarily shut down funding from Restores.

Mr. McDonald reported that if the Town is willing to sell, the local Chapter would appreciate some consideration on price and development fees. Mr. McDonald explained the Habitat for Humanity financing model, noting that a family was not required to make a down payment, and would have a zero interest mortgage geared to 25% of income. Once built, the mortgage was set for the house's market value and was held by Habitat. Habitat has the first right to buy back the house, should the family wish to move.

5.3 Dale Landry of 13 Rosetta Street addressed Council further to his letter provided under item 4.4 with respect to his request that the parking regulations by-law be amended to permit parking on grassed boulevards. Mr. Landry said that the current prohibition was not consistent with other similarly sized communities such as Bracebridge and Gravenhurst and he expressed concern that the prohibition is not supportive of increased housing density which will come with increased need for parking. Mr. Landry noted that his house is constructed on a reduced size lot, and part of the original agreement was to permit boulevard parking. Mr. Landry requested that the Town change the terms of the By-law to permit boulevard parking.

Director of Development and Protective Services Dave Thompson noted that he spoke with the By-law Enforcement Officer who said that that vast majority of municipal parking by-laws do not permit parking on grass boulevards and that this prohibition has been in place for at least as long as he has been with the Town - more than 10 years, and that it is enforced on a regular basis as necessary.

Councillor McCann suggested that if Mr. Landry has documentation permitting parking on grassed boulevards, this be considered for grandfathering into existing regulations.

Councillor Borneman suggested that the direction to staff shouldn't be limited to just this situation, but rather that parking regulations should be considered in the context of increased housing densities of the future.

Councillor Beleskey noted that the boulevard also serves a purpose for snow storage, and this needs to be considered if parking is permitted on boulevards.

Whereas the Town Dock is owned by the Federal Government, and the Town of Parry Sound holds a Head Lease for its operation; and

Whereas the Federal Government is not maintaining this infrastructure and the burden of the repairs is falling to the Town of Parry Sound; and

Whereas the Federal Government receives a payment of the gross revenues of the Town Dock; however, the municipality runs a net deficit to operate the Town Dock and keep it at a minimum maintenance level; and

Whereas use of the Town Dock has increased with emergence of the Great Lakes Cruise Ship Industry; and

Whereas the Cruise Ship Industry provides economic spin off benefits for the broader Great Lakes Area; and

Whereas the increase or the size and number of Cruise ships attending the Town Dock is causing increased deterioration to the Town Dock;

Therefore be it resolved that the Town of Parry Sound Council requests the Federal Government to properly maintain and invest in the federal infrastructure of the Town Dock through upgrades and maintenance that will allow for the increased usage of the facility to continue and allow for the economic benefits to the broader Great Lakes area to also continue without the financial burden falling to the Town of Parry Sound.

And further that this resolution be sent to the Honourable Minister of Intergovernmental Affairs, Infrastructure and Communities Dominic Leblanc, the Honourable Minister of Transport Omar Alghabra, and Parry Sound Muskoka MP Scott Aitchison.

Whereas Codes of Conduct for local municipal leaders should be updated to include workplace safety and harassment policies; and

Whereas the Association of Municipalities of Ontario (AMO), the Rural Ontario Municipal Association (ROMA), the Ontario Big City Mayors and over 155 municipalities in Ontario all passed resolutions calling for government legislation to stop harassment and abuse by local municipal leaders, and

Whereas on May 31, 2023 the Ontario government voted against enacting Bill 5, Stopping Harassment and Abuse by Local Leaders Act, 2023;

Now therefore the Council of the Town of Parry Sound:

- 1. supports the recommendations of AMO that:
- Codes of Conduct should be updated to include workplace safety and harassment policies;
- Codes of Conduct should have an escalating enforcement mechanism through administrative monetary penalties that recognize local circumstances;
- Integrity Commissioners should have better, standardized training to improve consistency of decisions across the province;
- in the most egregious cases, such as harassment or assault, municipalities should be able to apply to a judge to remove a sitting member if recommended by an Integrity Commissioner;
- a member removed under this process should be unable to sit in another election during the term of office removed and the subsequent term; and
- 2. urges the Ontario Government to table and pass legislation to make these changes as soon as possible; and
- 3. forwards copies of this resolution to The Honourable Doug Ford, Premier of Ontario; Honourable Stephen Clark, Minister of Municipal Affairs & Housing; Honourable Charmaine Williams, Associate Minister of Women's Social and Economic Opportunity;
