# 2. Public Meeting - N/A

## 3. Questions of Staff

**3.1** In response to Councillor McCann's inquiry regarding the gas leak in the downtown last week, Director of Development & Protective Services/Fire Chief Dave Thompson noted that it was a result of construction. Many resources were called upon to assist with the situation to ensure road closures and evacuations of nearby residents. Parry Sound and McDougall Fire Departments as well as OPP, EMS and various public works departments, Lakeland Power and the gas utility were on hand to assist.

**3.2** In response to Councillor Keith's inquiry regarding the Parry Sound Fire Department Open House last weekend, Director of Development & Protective Services/Fire Chief Dave Thompson noted that it was a great success with over 100 children in attendance along with adults. They ran out of food and toys which is a good problem to have, everyone left happy and full.

**3.3** In response to Councillor Keith's inquiry about the status of tree branches overhanging sidewalks, specifically on Bowes Street, Director of Public Works Mike Kearns responded that public works staff have been concentrating on trimming and removal of problem trees within the Town over the past week or so. Homeowners should be trimming their overhanging trees & bushes. Councillor Keith requested that staff examine existing by-laws with reference to tree trimming & encroachment onto Town property.

**3.4** In response to Councillor Keith's inquiry about why Bowes Street in the area of Albert Street was down to one lane recently Manager of Operations Vinni Bonazza

replied that staff were performing ditching to improve storm water drainage which is a regular maintenance item.

**3.5** Councillor McCann noted that he often sees garbage & recycle bins left right on the sidewalk either when full or after they have been emptied. He inquired if there is a by-law for obstruction of sidewalks to which Director of Public Works Mike Kearns responded that yes there is, he will ask staff to speak to contractor to ensure these are left on the boulevard after emptying and not left on the sidewalks.

# 5. Deputations

# 5.1 Adrian Winn and Keith Duncan - Request to reduce speed limit on Wood St.

Adrian Winn and Keith Duncan provided some insight into the issues faced by children and adults alike when travelling on foot in the area of the Isabella, Wood, Marion, Salt Dock Road area. These issues include vehicles travelling too fast, no sidewalks, bus stop zones and the trees on town property at 35 Wood St impeding sight lines. Mr. Winn's daughter stepped onto the abutting grass last year & was stung 30 times when she stepped in a hornets ground nest. They are requesting consideration of a speed limit reduction from 50 kmph to 40 kmph and a 4 way stop to be installed at the corner of Marion & Wood Street. While it is understood that engineering designs are now in the hands of both CN & CP to correct the sharp corner and lack of sidewalks across St. Charles Crossing this is taking too long. As removal of the trees at 35 Wood St will be happening when the realignment is completed the suggestion is to remove them now to improve the sightlines.

#### 5.2 Christina Caap, Barb Harding, Dom Bot - Pickleball

Christina Caap noted that the pickleball players are a diverse group with players well up into their eighties. They would like to return to a drop in format for pickleball play at the BOCC, the registration type format doesn't work well for including newcomers to the sport. They would also like to have more weekly opportunities to play over the winter, from looking at the events calendar it appears there may be space both Monday and Friday mornings. Evening sessions for those still working is a good idea, from 6 to 8pm rather than 5 to 7pm as currently slotted. As well they would like the ability to use the ice surface during late spring and summer, ideally 5 morning per week from 9 to 11 am. The group is willing to work with staff to come to a solution and are thankful to be able to use the BOCC.

Barb Harding focused on the positive economic impacts that the participants of pickleball make to the Town with local purchases of clothing, footwear, equipment and through the social activities of the group planning lunches at area restaurants and attending shows. She noted that they have 2 pickleball groups in the area totally 80 members.

Dom Bot wished to express what an overwhelming success the pickleball drop-in program was last year and share some of the benefits that came from it. Pickleball is as much a social outing as it is a physical event, many meaningful relationships are being fostered. Several social outings have been organized to area events and dining which gives everyone a sense of belonging and perhaps even more important a sense of community and wellness. Pickleball is North America's fastest growing sport with many people picking their vacation spots with pickleball facilities. They would be happy to partner with the Town in any way possible and are hopeful that a mutually beneficial pickleball schedule can be arrived at.

THEREFORE BE IT RESOLVED THAT the Town of Parry Sound supports the request of the City of Cambridge that the Ontario Government amend s.205.1 of the HTA to permit municipalities to locate an ASE system permanently or temporarily on any roadway under the jurisdiction of municipalities and as determined by municipalities and not be restricted to only community safety zones and school safety zones; and

THAT a copy of this resolution be forwarded to the Ontario Minister of Transportation, the Ontario Minister of Municipal Affairs and Housing, MPP Graydon Smith, the Association of Municipalities of Ontario (AMO) and all Ontario Municipalities.
