Council held a public meeting to consider an application for consent to sever lands under Section 53 of the Planning Act. The purpose of the proposed Application B/23-04 would result in a 3.8 square metre lot addition in favour of the neighbouring lands to the north (5 Gibson Street) in order to provide additional space on the benefitting lands. No new lots would be created as a result of the proposal.

No one spoke either in favour of or in opposition to the application for consent.

3. Questions of Staff

- 3.1 In response to Councillor Keith's inquiry on the status of the gazebo at the Town Dock, Director of Public Works Mike Kearns reported that he had had a conversation with the contractor, who assured him then that work would be done; as this is now a couple of weeks ago, and it hasn't been done, Mr. Kearns said he will follow-up with the contractor.
- 3.2 In response to Councillor McDonald's inquiry regarding vandalism at Kinsmen Park, Mr. Kearns indicated that he had no information on this, but would follow-up.
- 3.3 In response to Councillor Borneman's inquiries regarding winter ready-ness, and whether the stanchions on Church and Joseph Streets reduced speed, Mr. Kearns reported the department is ready for winter, and that the stanchions have been removed before plowing starts. The data shows that there was a positive impact as a traffic calming measure to slow traffic in addition to signage.
- 3.4 In response to Councillor McCann's inquiry regarding the community support services van, Mr. Kearns reported that it is being constructed and finalized according to

specifications of Community Support Services, and he will follow-up to learn when it is expected to be delivered.

4.1 Catherine Fife, MPP Waterloo; RE: Request support for Bill 21, Fixing the Long-Term Care Amendment Act (Till Death Do Us Part), 2022. Referred to West Parry Sound Health Centre and associated Long-Term Care facilities for recommendation.

5. Deputations

5.1 Anne Bossart RE: Public Gardens & Gardening in Parry Sound

Anne Bossart addressed Council from a prepared power point presentation, identifying the difference between planting flowers and gardening, with the former being a part of the latter. Ms. Bossart noted locations in Town that have gardens, and the groups responsible for maintaining them, including Parks & Recreation staff, individual volunteers, the Horticultural Society, the Downtown Business Association, Georgian Bay Biosphere, and Tower Hill Gardeners, with highlights of this year's gardening activities and installations at Tower Hill.

Ms. Bossart urged the Town to move forward in updating the Waterfront Master Plan in concert with the Parks, Recreation and Culture Master Plan completed this year. She shared observations and recommendations from the latter plan, noting discrepancies in how the Town maintains parks and outdoor facilities from a landscaping and maintenance standpoint. The Plan recommendations included: #16 - develop maintenance, landscaping and horticulture standards for the Town Park system and facility exteriors and build-up the necessary staffing and equipment resources to achieve them; and #17 - continue to support volunteer led gardens and horticulture initiatives and develop standards of support while encouraging new volunteer led opportunities.

Upon concluding her presentation, Ms. Bossart inquired as to why the Town doesn't plow the fire route at Tower Hill, since it is empowered to ticket vehicles parked there.

Director of Development & Protective Services Dave Thompson responded that he would review the situation and get back to Ms. Bossart and Council.

5.2 Greg Mason, Georgian Nordic Outdoor Activity Ctr. RE: Capital Campaign

Greg Mason addressed Council from a prepared power point presentation regarding history and activities at the Georgian Nordic Outdoor Activity Centre, and its current 40th Anniversary Future Fund capital campaign over 3 years with a goal to raise \$1m for major improvements. With a \$150,000 anonymous donation, \$650,000 in grant applications pending, Mr. Mason noted that outstanding was a Future Fund Goal of \$200,000. Mr. Mason identified the capital projects, being a 1,200 sq ft. picnic shelter with 2 permanent and 2 enclosable walls as overflow for groups and events, a new 960 sq ft heated garage, with a 400 sq ft drive shed attached, and new trails and grooming equipment. Mr. Mason requested Council consider a donation of between \$10,000 to \$12,000 spread over 1 to 3 years, reflecting membership of 50-60% residing in the Town.

Director of Finance Stephanie Phillips confirmed that she would keep track of this request as a community group request within the budget process.

WHEREAS Section 87 of the Legislation Act, 2006 defines "newspaper", in Acts and regulations requiring publication, as a document that,

- a) is printed in sheet form, published at regular intervals of a week or less and circulated to the general public, and
- b) consists primarily of news of current events of general interest; ("journal"); and

WHEREAS Ontario Municipalities are required to follow prescribed publication and notice requirements of Provincial Acts and Regulations; and

WHEREAS the Town of Parry Sound and many other municipalities in Ontario cannot comply with publication requirements in Provincial Acts and Regulations since effective September 15, 2023, Metroland Media Group ceased the print publication of its weekly community newspapers across Ontario, moving to an online-only model, and there are

no other local news publications in Parry Sound fitting the definition of "newspaper" per the Legislation Act,

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Town of Parry Sound does hereby request the Provincial government to make an amendment to the Legislation Act, 2006 to include on-line publications as an acceptable means of complying with public notice requirements that refer to newspaper publication in Provincial Acts and Regulations; and

THAT this resolution be forwarded to the Minister of Municipal Affairs and Housing, Paul Calandra; Parry Sound-Muskoka MPP, Graydon Smith; The Association of Municipalities of Ontario (AMO); and all Ontario Municipalities.
