#### 3. Questions of Staff

3.1 In response to Councillor McDonald's inquiry requesting updates of the Friday night incident with a person on top of the observation tower at Tower Hill, Fire Chief Dave Thompson reported that the incident involved police and fire crews at the scene with a hole cut in the tower in order to bring the individual down. While there is no structural damage, it is not safe to head up to the top floor and the tower is currently closed until repairs have been made. Mr. Thompson said he is currently working with the OPP regarding the cause of the incident and what opportunities there are to pursue compensation.

Mayor McGarvey thanked the various Fire Departments, paramedics and OPP who attended at the scene. Chief Thompson further explained the mutual aid system used to respond to the incident.

- 3.2 In response to Councillor Keith's inquiry regarding the status of follow-up to the August, 2023 Council direction that public washroom hours be extended in the summer, Director of Development & Protective Services Dave Thompson reported that staff is still working on developing a plan that deals with and aligns hours for washrooms at Big Sound Marina, Waubuno Beach and the Town Dock, some of which necessitates negotiations with contractors.
- 3.3 In response to Councillor Borneman's inquiry regarding Earth Day activities, Manager of Parks & Recreation April McNamara reported that partners including Early On, the Parry Sound Public Library, and the Parry Sound Friendship Centre will be hosting activities on Saturday April 20 from 9 AM to noon at the Bobby Orr Community Centre. Ms. McNamara identified additional activities in April, including 1) Pitch-in Week April 20-27; 2) Paint Winter Goodbye from 10 AM to 2 PM on Sunday, April 7 with families invited to get artistic on the ice surface before the ice is taken out; and 3) Sport, Rec & Leisure Fair on Thursday, April 18, from 5 7 PM at the BOCC providing parents with an opportunity to learn about all the activities going on in Parry Sound.
- 3.4 In response to Councillor Ashford's inquiry regarding how areas in Town with a bad odour might be dealt with, Mr. Thompson reported that the Clean Yards By-law has provisions to respond to odours.
- 3.5 In response to Councillor McCann's inquiry as to how to avoid eye injury during the solar eclipse on Monday, April 8th, Mr. Thompson advised to avoid looking directly at the sun.

## 5. Deputations

### 5.1 Eric McIntyre - Installation of New Radio Read Water Meters

Mr. McIntyre addressed council with respect to the Town's planned installation of a water meter at his residence, noting that for 9 years he has been charged a flat rate, even though he has a water meter.

Mr. McIntyre suggested that if the current meter is faulty, use of a correction factor instead of switching out the meter would be a simpler way of dealing with it. Mr. McIntyre noted that he received no response from the Town regarding leakage but would be happy to pay a surcharge on lost revenue regarding leakage.

Mr. McIntyre requested that the Town provide a project description, and business case for this project of new meter installations as he expected that the program will cost hundreds of dollars in labour and materials for each installation and therefore hundreds of thousands of dollars for the entire project. He requested to know how the project is being financed since he has been told the meter installation will be at no cost to himself and requested a response to all of these questions by April 24th before the new meter is to be installed.

Director of Public Works Mike Kearns reported that a response to Mr. McIntyre's previous request by letter on the same matter was sent to him by e-mail this date.

## 5.2 Bob Baranski, Save Georgian Bay, Opposition to OPS

Bob Baranski of the organization Save Georgian Bay addressed Council noting the movement of opposition to TC Energy's planned Ontario Pumped Storage (OPS) project. Mr. Baranski said that the project is a bad deal economically, with great risk to contaminate Georgian Bay and the Niagara Escarpment with forever chemicals.

Mr. Baranski said that TC Energy wants a 50 year contract for the OPS which will not be on-line until 2035. With consumption set to reduce, the high demand today may not be an issue by the time TC Energy's OPS project is completed. Mr. Baranski suggested battery costs are trending down, are a better solution and more efficient; and that Tesla says batteries last 20 years and can be recycled.

With respect to cost, Mr. Baranski said that the price tag has skyrocketed with the Minister of Energy admitting that he did not know ultimately how much this will cost, heightening the risk to taxpayers. Mr. Baranski noted that the province's own Independent Electricity System Operator (IESO), the expert on the electricity market and bulk electrical system in Ontario has recommended against this project.

Amanda Greenfield, and Executive Director of the Georgian Bay Association Rupert Kindersley, also addressed Council with concerns about the project, identifying the more than 20 registered endangered species, excavation of ordnance left on Department of National Defence (DND) property and absence of a public tendering process in awarding the project to TCE. Mr. Kindersley also said that the IESO has largely determined that battery storage is what they want, as it can deal with current storage needs, and that storage projects which pump water uphill to have it run downhill is old technology which uses and loses electricity in an inefficient manner.

## 5.3 TC Energy - Ontario Pumped Storage (OPS) Project, Meaford

John Mikkelsen, Director of TC Energy's power and energy solutions addressed Council on behalf of the project noting it was in partnership with Saugeen Ojibway Nation. Mr. Mikkelsen said that this project is important to achieve net 0, meaningful towards reconciliation and contributes towards jobs. Prior to the start of the project, environmental assessments will be undertaken set to take 3 years.

Mr. Mikkelsen noted the population growth in Ontario of 450,000 last year necessitating the need for energy storage and said that pumped storage is a clean energy initiative.

Mr. Mikkelsen noted that batteries will have an important role in the energy system and that the project is not a matter of one or the other, but that the life span for batteries at 40 years is short with the supply chain dominated by China. Mr. Mikkelsen noted that both the City of Owen Sound and Town of Meaford have provided resolutions of conditional support. Mr. Mikkelsen recommended that Council review the Ministry of Energy's report *Powering Ontario's Growth*, for more information on energy needs.

Mr. Mikkelsen responded to questions from members of Council related to how the pumped storage system works and the impact on electricity in Ontario.

Whereas most Small Urban Municipalities are economic hubs serving an area much larger than their respective municipality;

Whereas they provide the infrastructure essential to the delivery of a wide range of business, economic, social and educational services as well as a range of housing options that benefit surrounding municipalities;

Whereas the surrounding municipalities that benefit from those services do so without contribution to the infrastructure costs which are entirely born by Small Urban Municipalities;

Whereas Small Urban Municipalities face increased social and fiscal pressures as a result of providing infrastructure in support those services;

Whereas this results in Small Urban Municipalities having disproportionately higher cost structures as compared to more rural municipalities;

Whereas these services available in Small Urban Municipalities also leads to a much higher proportion of their assessment base being exempt from property taxation;

Whereas these factors, when combined, result in significantly higher property tax rates in Small Urban Municipalities compared to neighbouring municipalities;

Whereas criteria used in federal and provincial funding programs doesn't effectively distinguish between the needs of these Small Urban Municipalities as compared to other municipalities;

Whereas the most cost-effective and timely way to increase the housing supply is to leverage existing urban infrastructure through infill development;

Now therefore be it resolved that provincial and federal governments be requested to review their funding program criteria with the objective of providing a greater focus on funding infrastructure in Small Urban Municipalities;

That the provincial and federal governments continue to work together to coordinate infrastructure funding to ensure the optimum return on their combined infrastructure investments;

That as part of that coordination the provincial and federal governments undertake a 3rd

party review to determine how all levels of government can be assured their

infrastructure investments deliver the optimum return on investment in a timely manner,

and small urban municipalities responsible for such infrastructure are appropriately

incentivized for taking on such significant risks; and

That this resolution be forwarded to the federal Minister of Housing, Infrastructure and

Communities, the provincial Minister of Finance, the Minister of Municipal Affairs and

Housing, the Minister of Infrastructure, MP Scott Aitchison, MPP Graydon Smith, the

Association of Municipalities of Ontario (AMO), the Ontario Small Urban Municipalities

(OSUM) and the Federation of Northern Ontario Municipalities (FONOM) and the
