Barb Barrett of PSSCC#11 on behalf of 11 Salt Dock Road requested an update since her February 6, 2024 deputation on the status of transfer of the watermain from the Condo Corporation to the Town. She noted that the Corporation is run as a non-profit with 92 homeowners and they are unable to get insurance for this, causing great concern in event something were to break or be damaged.

noted that in order to make it a priority now, staff will have to drop other priorities.

Whereas the property is approximately 5.4 acres of land, excluding the water lot;

Whereas the property can be the cornerstone of the development of the waterfront;

Whereas the Town owns waterfront property on either side of the MNRF base with the potential to enhance and create a more comprehensive redevelopment plan;

Whereas the Town is currently in the process of updating its Official Plan and Waterfront Masterplan;

Whereas the involvement of the Town in the process to dispose of the property will help ensure the future use of the property achieves the community's vision;

Whereas Infrastructure Ontario, under the Minister of Infrastructure manages the divestiture process;

Now Therefore be it Resolved that the Minister of Infrastructure, the Honourable Kinga Surma be requested to include the Town in the divestiture process; and

That this Resolution be sent to the Minister of Natural Resources and Forestry, the Honourable Graydon Smith.

9.4.1 OP Review Update

Jamie Robinson, Kathy Suggitt and Chloe Patten of MHBC Planning Consultants provided an overview of the Town's Official Plan process from a prepared power point presentation circulated with the agenda. The three phases of Background Research from Sept 2023 to March 2024, Draft official Plan Update from February, 2024 to August, 2024 and Final Official Plan from September 2024 to November 2024 were identified, and the following were aspects reviewed in more detail:

Three themes emerged from the Community Engagement and Discussion Paper, being

- 1. Importance of the natural environment and natural setting of Parry Sound;
- 2. The challenges and opportunities relating to managing growth and development, and the change that is starting to occur; and,

3. Finding a way to balance these to align with the future vision of the Town.

Parameters of the Official Plan Update are:

- Updates based on major themes/topic areas and concepts that have emerged through engagement efforts;
- 2. Legislative changes;
- 3. Minor updates; and,
- 4. Reorganization to ensure the document is more user-friendly.

An Official Plan Community Structure Map is being developed to show a long-term high-level vision with four main pillars of Living Area, Economic/Mixed Use Area, Central Commerce Area and Harbour Area.

The 8 broad land use designations currently in the Official Plan are proposed to be reduced to allow more flexibility and encourage a greater mix of uses; i.e.

- Reduce from 3 urban residential designations to 1 designation and establish criteria to evaluate appropriateness of different densities.
- Reduce the number of commercial/mixed use area designations and encourage more mixed-use areas beyond Joseph Street.

Other section updates include:

- Encourage a greater diversity of housing types and options across broader areas of Town.
- Strengthening the year-round economy by leveraging tourism and promoting a diversity of jobs.
- Align the land use and development policies with infrastructure considerations.

Next steps include

- Discussion Paper 2 to be released for public comment.
- Comment period open until May 29, 2024 via an online form or in writing to the Town's OP email account – officialplan@parrysound.ca

First draft of Official Plan expected to be released early summer.

Councillor Keith noted that she thought there would be more future development along Great North Road and that the Official Plan should reflect this. Mr. Robinson responded that these comments were welcomed at this early stage and the boundaries of the community structure may change to reflect that.

In response to a query regarding the reason to reduce the number of broad designations, Mr. Robinson noted that land use can be controlled through policy as opposed to specific designations which if there are fewer, can provide greater flexibility. The communities of Barrie, Orillia and Midland have taken this approach.

CAO Clayton Harris agreed to Councillor Keith's suggestion that this information be promoted both on the Town's website, through social media and on radio.
