## 3. Questions of Staff

- 3.1 In response to Councillor McCann's inquiry regarding the Stockey Centre sign, CAO Clayton Harris reported that staff have been trying to get parts for the sign, and he'll follow-up to determine status.
- 3.2 In response to Councillor Keith's inquiry regarding how the content of retired Admin Assistant Ann Hurdman is being handled, Mr. Harris reported that Public Works administrative staff are assisting with cemetery duties
- 3.3 In response to Councillor Keith's inquiry regarding manholes and micro surfacing on Bowes St. Manager of Operations Vinni Bonazza reported that he is awaiting on a date from the contractor to come back and will fix.
- 3.4 In response to Councillor Keith's inquiry regarding the elimination of the path in front of west side Church Street residents where roadwork is now being done and the potential loss of Canada Post deliveries to these residences, Director of Public Works

Mike Kearns responded that he can open discussions with Canada Post on access through the back lane and whether the loss of the path in front will be a limiting factor regarding postal delivery.

- 3.5 In response to Councillor Borneman's inquiry regarding the surfacing of the pathway in front of the west Church Street residences, Manager of Operations Vinni Bonazza reported that it will be asphalted.
- 3.6 In response to Councillor McDonald's inquiry regarding washrooms at the Town Dock, Director of Development & Protective Services Dave Thompson reported that the washrooms are substandard, and the intention is to obtain a redesign and costing for the 2025 budget with work anticipated to be completed prior to the 2025 season.
- 3.7 In response to Councillor McDonald's inquiry regarding status of Seguin St. bridge repairs, Mr. Bonazza said that the project is going well and on schedule.
- 3.8 In response to Councillor Beleskey's inquiry regarding staff's experience with electric vehicles as part of the Town's fleet, Mr. Kearns reported that a report can come before Council after more time using the vehicles to provide a greater data set. Mr. Kearns also noted Lakeland Power has indicated that charging stations should be operational at the BOCC and Stockey Centre by the end of September.

# 5.1 Bill Mardimae, Gardens of Parry Sound, Seniors Apartments Development

Bil Mardimae addressed Council on the background of The Gardens construction history, noting that phase 1, being 70 retirement suites was constructed in 2013 and 35 suites were added in 2019. With additional demand for seniors housing, Mr. Mardimae reported that The Gardens is looking at expanding with 2 buildings of 30 and 40 apartment units each, one of which will require the Town's approximate 2 acre right of way adjacent to The Garden's property in order to build. Mr. Mardimae noted that he has spoken about the project with Town staff already and had a discussion with Canadore College about the possibility of assistance with respect to student housing.

In response to Councillor inquiries on potential next steps to transfer the requested property, Director of Development & Protective Services Dave Thompson reported that the disposal by-law requires a specific resolution by Council for a direct sale and that the discussion with Mr. Mardimae included potential conditions if staff were to make such a recommendation to Council. Mr. Thompson noted that this property was declared surplus in 2017, and was moving through a process for RFP for highest and best use; however, got postponed indefinitely when the pandemic hit.

Community-Building Funds, which is administered by the Association of Ontario

Municipalities of Ontario (AMO) on behalf of the Federal government;

And whereas the funding allocations are less that 2% year over year for the next 5 years;

And whereas the amounts allocated in the past 5 years were less than 2% year over year;

And whereas non-residential construction price inflation has risen by 29% since the end of 2020 and municipalities are facing soaring costs for infrastructure projects without a corresponding growth in revenue;

And whereas there is a requirement for municipalities to complete an asset management plan and a housing needs analysis;

And whereas both of these plans show the large funding gap between infrastructure and housing needs and funds available from property taxation;

And whereas The Town of Parry Sound has over \$369 million in core infrastructure assets and, like other municipalities, its infrastructure is aging and in need of upgrades and replacement;

And whereas The Town's Asset Management Plan requires \$14.8 million annually to maintain existing assets which, based on current available funding, is resulting in an annual infrastructure deficit of over \$9.9 million;

And whereas municipalities are facing a gap in federal infrastructure funding as the 10year Investing in Canada Infrastructure Program has come to an end;

Now therefore be it resolved that the Town of Parry Sound calls on the Federal Government to provide a supplement to the allocations provided to municipalities under the AMO CBBF agreement for 2024 - 2028 for the same amount that was allocated, effectively doubling the allocation for those years;

And further that this resolution be forwarded to MFOA, AMO, MP Scott Aitchison, and Federal Finance Minister Chrystia Freeland.
