3. Questions of Staff

- 3.1 In response to Councillor Keith's inquiry regarding the Ontario Recreation Facilities Association (ORFA) 2024 Tony Brenner Mentor Award to April McNamara, Director of Public Works Mike Kearns confirmed that the award was made to Ms. McNamara virtually and he will find out when the award is to be provided in person and report back to Council.
- 3.2 In response to Mayor McGarvey's inquiry regarding servicing and emergency response by Lakeland Power, Director of Development & Protective Services/Fire Chief Dave Thompson reported that there were two components to constructive conversations with Lakeland held last week, being preventative measures and reactive responses. Mr. Thompson reported that their program of pole replacement and other upgrades are preventative measures in attempting to reduce outages, and that their ability to disconnect remotely, to be activated once processes are in place, will be a means of responding to emergencies in the future.

5. Deputations

5.1 Nadine Hammond, Curator/Manager WPS District Museum

From a prepared power point presentation, Curator/Manager Nadine Hammond of the West Parry Sound District Museum gave an overview of 2024 program highlights including displays on curling, legacy of the steamer Waubuno, reconnecting me to you - a project identifying individuals in photos, and people of the watershed - photos by John Macfie.

Ms. Hammond provided the 2025 budget and made a request of the Town for funding in the amount of \$47,000 being close to the 0.04% of the Town's property tax, being the formula for requests to municipalities as introduced last year.

In response to Councillor Keith's inquiry regarding admissions by donation for 2024, Ms. Hammond indicated that she would follow-up with information for Council.

5.2 Selena Martens, CEO; Rola Fraser, Manager, Collections and Community Engagement PS Public Library

From a prepared power point presentation circulated with the agenda, Parry Sound Public Library CEO Selena Martens and Manager of Collections & Community Engagement Rola Fraser gave an overview of the Library's programming highlights and services offered in 2024 and concluded with a request for 2025 funding from the Town of \$349,914.90, marking a 5% increase of \$16,662.61 over 2024.

In response to Councillor Keith's inquiry regarding a further breakdown of statistics, Ms. Martens noted that they will consider this for future years.
